

Downtown Greenwood Farmers' Market Fine Arts & Quality Crafts Rules & Regulations

All arts and crafts must be juried by the arts committee before they are offered for sale at the Market. Any new items must also be approved by the art committee before being offered for sale. Only original handcrafted, finished items shall be displayed and offered for sale at the Market. All arts and crafts offered for sale at the market must be handmade from raw materials.

The art committee reserves the right to remove or reject any item.

All work will be juried on originality, craftsmanship and imaginative use of materials. DGFm reserves the right to ask that the art vendor remove any items that have not been approved by the art committee. Refusal to do so may result in removal from the Market.

Art Guidelines:

1. Only original artwork will be accepted. Everything must be made by the exhibitor.
2. Only work listed in the categories below is accepted.
 - a. Original Paintings
 - b. Original Drawings, Graphics and Photography
 - c. Multi-media and Sculpture
 - d. Pottery
 - e. High Quality, Handmade Jewelry
 - f. Other Items as deemed appropriate by the Art Committee
3. Items no allowed to be sold include:
 - a. Plastic
 - b. Styrofoam
 - c. Greenware and Unfinished Porcelain
 - d. Plastic or Silk Flowers
 - e. Screen printed t-shirts or other screen printed clothing
 - f. Products made from kits or pre-fabricated items
 - g. Purchased items you have decorated
 - h. Cloth cut-outs, carpet art or pre-printed cheaters cloth

Booth Space Guidelines:

1. Booths must fit in a 10' x 10' space.
2. We regret that no request for specific booths, locations or spaces can be honored.
3. Art Exhibitor is responsible for tents, tables, chairs or any other items that he/she may need.
4. Produce Vendors have priority on Market Tents. If at 8:00 AM start time a Market Tent is available, Art Exhibitors may use Market Tents that day.

5. Vendors with a 50% or greater produce inventory at start of Market will be considered a Produce Vendor.
6. Set up is from 7:00-8:00 AM Saturday mornings during Market Season.
7. Exhibition fee is \$10.

Hold Harmless Clause:

All authorized vendors participating in the Downtown Greenwood Farmers' Market are individually and severally responsible for any loss, personal injury, death, and/or other damage that may occur as a result of the vendor's negligence or that of its servants, agents and employees. All vendors hereby agree to indemnify and hold harmless Downtown Greenwood Farmers' Market and Main Street Greenwood from any loss, cost, damages and other expenses, including attorneys' fees, suffered or incurred by Downtown Greenwood Farmers' Market and Main Street Greenwood by reason of the vendors' accidental or deliberate negligence or that of its servants, agents and employees; provided that the vendors shall not be responsible or required to indemnify Downtown Greenwood Farmers' Market and Main Street Greenwood for negligence, its servants, agents and employees. Because no insurance is provided to participants in Downtown Greenwood Farmers' Market, each vendor is responsible for his/her own product liability insurance.
